WAIVER AND RELEASE FROM LIABILITY

In consideration of being permitted to for any purpose any event, or being to compete, officiate, observe, work for, or any purpose participate in any way in the event, each of the undersigned, for himself, his personal representatives, heirs, next of kin, acknowledges agrees, and represents that he has, or will immediately upon entering any of such event areas, and will continuously thereafter, inspect such event area or areas and all portions thereof which he enters and with which he comes in contact, and he does further warrant that his entry upon such event restricted area or area and his participation, if any, in the event constitutes an acknowledgment that he has inspected such event areas and that he finds and accepts same as being safe and reasonably suited for the purpose of his use, and he furthers agrees and warrants that officials of such and will leave the event area(s);

1. Hereby releases, waives, discharges, and covenants not to sue The American Society of Interior Designers (ASID), The International Interior Design Association (IIDA), and The American Institute of Architects (AIA), the Chicago Park District, the promoters, other participants, operators, officials, any persons in any event area, sponsors, advertisers, owners and lessees of premises used to conduct such event and each of them, their officers and employees, all for the purpose herein referred to as "releasees". From all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any and all damage, and any claim or demands there of on account of injury to the other person or property or resulting in, but not limited to, personal and bodily injury to, loss or damage to property, death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in or upon the event area, and/or competing, officiating in, observing, or working for, or for any purpose participating in the event;
2. Hereby agrees to indemnify and save and hold harmless the releasees and each of them for any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the event area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releasees or otherwise.
3. Hereby assumes full responsibility for and risk of bodily injury, death, or property damage due to the negligence of the releasees or otherwise while in or upon the event area and/or while competing, officiating, observing, or working for, or for any purpose participating in the event.
4. Each of the undersigned expressly acknowledges and agrees that the activities at the event and adjacent areas are dangerous and involve the risk of serious injury and/or death and/or property damage. Each of the undersigned further expressly agree that the foregoing release, waiver, and indemnity agreement is intended to be as broad and as inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. The undersigned has read and voluntarily signs the release and waiver and indemnity agreement, and further agrees that no oral representations, statements, or inducement apart from the foregoing written agreement have been made. The waiver, release, and indemnification agreement specifically embraces each and every event sanctioned, authorized, or promoted by said releasees during the entire tournament and applies to each and every event, or activity herein above mentioned, and has the same effect as if executed after each and every activity or event in which the undersigned participates so that the parties herein intended to be released and indemnified shall be fully and effectively released and indemnified as to each and every event herein above described.

I agree that I have read and understand this Release of Liability and Indemnification Agreement, and enter into it on behalf of me and my family, spouse, heirs, executors and assigns, anyone acting on my behalf, including attorneys, agents, insurers and representatives.
